THROUGH ITS GLEANING PROGRAM, AFTER THE HARVEST PROVIDED 216,680 POUNDS OF FRESH FRUITS AND VEGETABLES TO AREA FOOD BANKS AND FEEDING AGENCIES IN 2015.

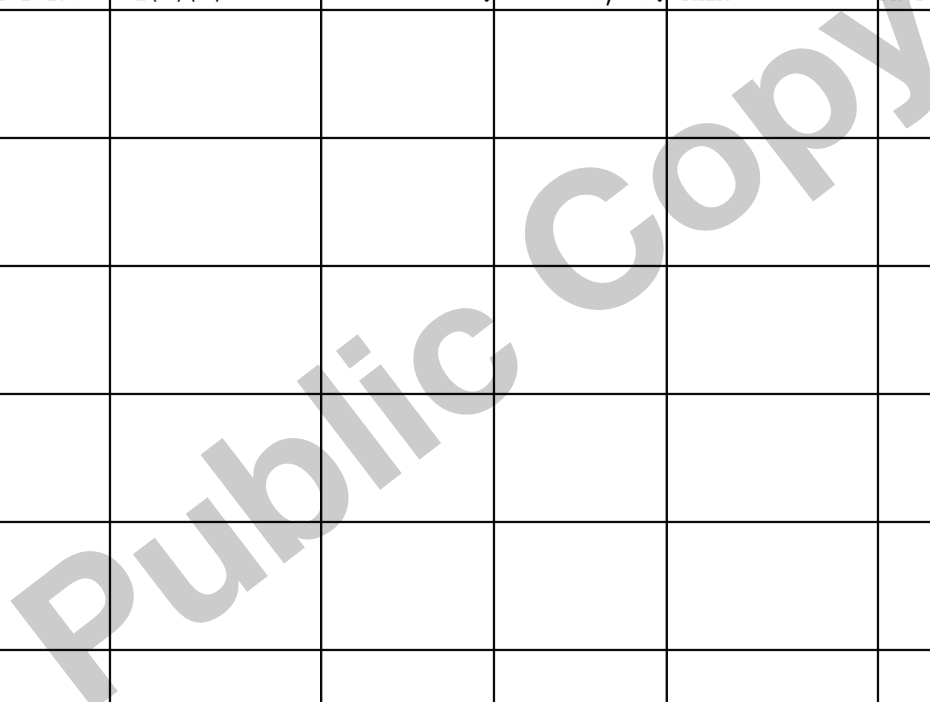

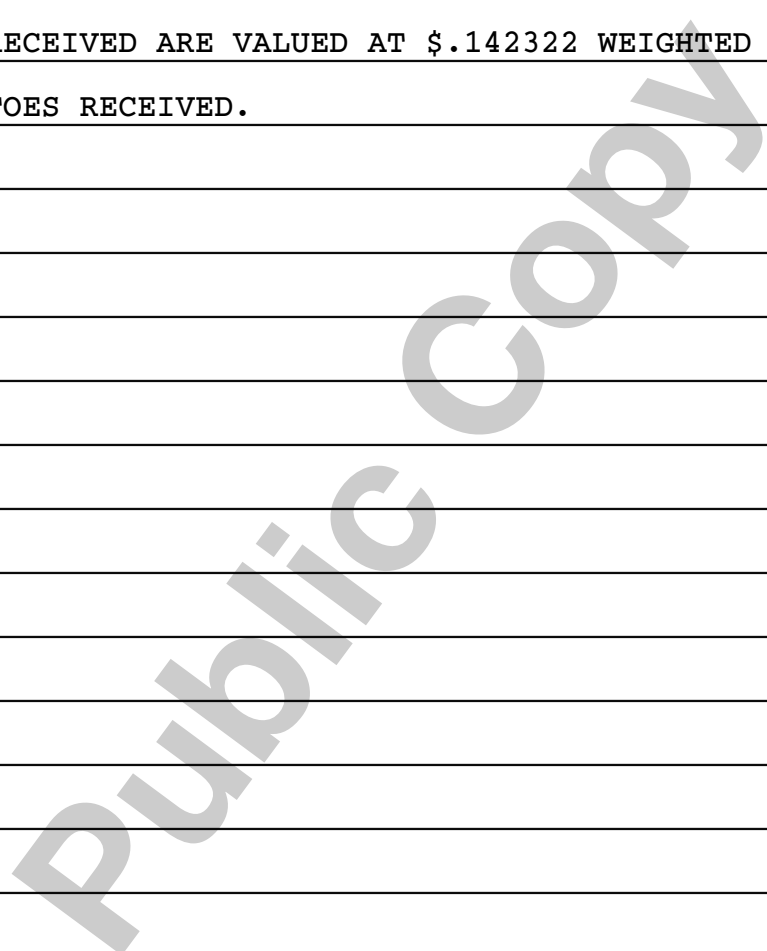
