PRODUCE RANGED FROM WHITE AND SWEET POTATOES TO PINEAPPLES AND WATERMELONS. THROUGH ITS PARTNERSHIPS WITH FARMERS CHOICE AND SOIK SALES, ATH HAS ACCESS TO MORE FRESH PRODUCE THAN WE CAN AFFORD TO DISTRIBUTE. WE COVER PACKAGING, HANDLING AND SOURCING FEES FOR THE DONATED PRODUCE.

THESE RESOURCES ARE FROM LOCAL AND REGIONAL PRODUCE DISTRIBUTION WAREHOUSES AND FARMS, FARMERS MARKETS AND UNIVERSITY EXTENSION'S TEST FIELDS. THIS ENABLED ATH STAFF AND VOLUNTEERS TO RESCUE ALMOST 1 MILLION POUNDS OF FRESH PRODUCE IN 2022, ALL OF WHICH WAS DELIVERED TO AGENCIES AND FOOD PANTRIES ACROSS THE KANSAS CITY REGION.
